New Business:

Chief Jenkins is ready to send the contract to attorney Snure for further review. He will also be setting up a meeting with Paul Priest, Chief Oberg, Chief Soto and MultiCare to discuss wall times at the hospitals.

- **Action Item:** Follow up after Attorney Snure reviews the AMR Contract.

Chief Vinci asked for an update on Unit 444. Jack Bush let the Chiefs know this is a 24-hour unit that operates out of Station 44 which covers the north end of District 9 and the south end of District 4. The unit will cover Post 1 during certain daytime hours and be backfilled by someone from the system when 444 is not there. The model will be evaluated for six weeks to determine its effectiveness, with potential adjustments to a 12-hour unit or other options. Billing is based on call type and residential zip codes. Runs in District 4 are billed at the district 4 rate. The caller type determines the billing rate. Unit 444 is staffed by AMR employees only.
